This template is for providing comments on the Exposure Draft (ED) of *Proposed International Standard on Auditing 240 (Revised), The Auditor's Responsibilities Relating to Fraud in an Audit of Financial Statements and Proposed Conforming and Consequential Amendments to Other ISAs (ED-240)*, in response to the questions set out in the Explanatory Memorandum (EM) to the ED. Detailed comments (if any): Incorporating Key Audit Matters (KAM) related to fraud indeed amplifies the workload for auditors. Although the auditor's responsibility is to execute the audit to attain reasonable assurance regarding whether the financial statements are free of significant misstatements due to fraud, it does not guarantee that all instances of fraudulent activity will be uncovered. Mandating auditors to include such language implies a proactive pursuit of fraud detection during audits. Moreover, integrating fraud-related KAMs might potentially confuse readers, as it could be misconstrued that detecting fraud is the primary mandate of auditors.

6. In your view, should transparency in the auditor's report about matters related to fraud introduced in ED-240 be applicable to audits of financial statements of entities other than listed entities, such as PIEs?
